# **MINUTES**

## June 20, 2019

### 3:00 PM

The special meeting of the Board of Trustees of the City of Boynton Beach Police Officers' Pension Fund was called to order on behalf of the Board by Mr. Athol on June 20<sup>th</sup> at 3:03 PM at 2100 North Florida Mango Road, West Palm Beach.

**TRUSTEES PRESENT**: Mr. Toby Athol-Chairman; Mr. Brian McDeavitt-Trustee; Mr. Daniel Dugger- Trustee; and Mr. Russell Faine-Trustee.

It should be noted that there was a quorum for the Board to have an official meeting.

### PUBLIC DISCUSSION:

No public comments presented.

## **CONSENT AGENDA:**

### **APPROVAL OF THE MINUTES:**

The Board reviewed the May 21<sup>st</sup>, 2019, City of Boynton Beach Police Officers' Pension Fund meeting minutes. Trustee McDeavitt made a motion to approve the May 21<sup>st</sup>, 2019 meeting minutes which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 4-0.

### WARRANTS:

The Board reviewed warrants 293 through 307. After review and consideration, Trustee McDeavitt made a motion to approve as presented, which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 4-0.

## **ACTUARY'S REPORT:**

In the presentation Mr. Strong gave at the May 21<sup>st</sup> meeting there was a question on two members who were listed in the report as vested terminated. These two members were Gladys Cannon and Eric Reynolds. After the meeting research was conducted and it was discovered the two members listed above were still active employees and were not vested terminated employees.

Mr. Strong recalculated the Actuarial Valuation report and presented two scenarios using a 20year UAAL Amortization period and 25-year UAAL Amortization period.

In reducing the Amortization Periods for Amortizing the Unfunded Actuarial Liability from 30 years to 25, a reduction to 25 years would increase the City contribution by approximately \$22,897.00 annually but save the plan approximately \$800,000.00 over the next 25 years.

In a second scenario going from 30 years to 20 years. This would increase the city contribution by approximately \$95,022.00 annually but save the plan approximately \$2.83 Million over the next 20 years.

After discussion a motion was made to lower the UAAL Amortization period from 30 years to 20 years by Trustee McDeavitt , which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 4-0.

There was also discussion on possible pension reform studies to be conducted by GRS. A motion was made to approve the study by Trustee McDeavitt, which was seconded by Trustee Faine. All Trustees voted yes, and the motion was passed 4-0. GRS was asked to complete the study on the following scenarios;

- 1) Increasing the member pension contribution by .5% and those monies will be used to offset the City contribution
- 2) Vested deferred at age 55 or age 50 with 10 years of service to be eligible for an early retirement
- 3) AFC Cap of 75% for members hired after 10/01/2015 AFC Cap of 87% for members hired before 10/01/2015
- 4) Increasing to 25 years of service for normal retirement for new hires
