after the resentencing hearings are completed. This is in fairness to both the Board and his

A joint recommendation was made to the DOAH Judges by Attorney King and Attorney Levy

(special counsel representing the Pension Board). The DOAH Judges will not hold the cases on

their docket in abeyance. Therefore, their joint recommendation was denied.

Attorney Levy also spoke to the Board and affirmed her recommendation to relinquish

jurisdiction in this matter without prejudice. Board member McDeavitt questioned if this would cause any issues reengaging the case after the resentencing hearings are completed. Both

Attorney Jensen and Levy gave opinions it would not.

Trustee Faine motioned to withdraw the cases from DOAH's jurisdiction until after the

resentencing hearings are completed. The motion was seconded by Trustee McDeavitt. After

some additional discussion, the motion passed 4-0.

Attorney Levy advised she will contact Attorney King and the two will file a joint motion to

withdraw the cases from DOAH's jurisdiction until after the resentencing hearings are completed.
